PROVINCIAL ORDINANCE NO. 1281-12

**AMENDING PROVINCIAL ORDINANCE NO. 1259, SERIES OF 2012
SPECIFICALLY THE PROVISION UNDER THE THIRD WHEREAS
CLAUSE ON THE EFFECTIVITY OF THE GENERAL REVISION OF
ASSESSMENT OF REAL PROPERTY VALUES OF THE PROVINCE OF
PALAWAN FROM THE YEAR 2013 BE CHANGED TO 2014**

WHEREAS, the Sangguniang Panlalawigan was in receipt of a letter from the Honorable Governor Abraham Kahlil B. Mitra dated September 21, 2012 requesting for the reconsideration of the effectivity year of the General Revision of Assessment of Real Property Values of the Province from 2013 to 2014;

WHEREAS, upon consideration, the Provincial Board deems it proper to change the effectivity year from 2013 to 2014 so as not to sacrifice the fiscal adequacy and the quality of local basic services to be rendered by the local government;

NOW, THEREFORE, upon motion by Honorable Rolando E. Bonoan, Jr. duly seconded;

**BE IT ENACTED BY THE SANGGUNIANG PANLALAWIGAN
IN SESSION ASSEMBLED THAT:**

SECTION 1. AMENDMENT – The Third Whereas Clause of the Provincial Ordinance No. 1259, series of 2012 be amended to be read as follows:

“WHEREAS, as provided under Section 219 of the aforementioned Code and as implemented by Local Assessment Regulations No. 1-92 dated October 6, 1992 of the Department of Finance, the Office of the Provincial Assessor shall undertake a general revision of real property assessments in the year 2012 and the revised assessments shall take effect in the year 2014.”

SECTION 2. REPEALING CLAUSE – Any provision of existing ordinances, rules and regulations inconsistent herewith are hereby repealed or modified accordingly.

SECTION 3. EFFECTIVITY – This Ordinance shall take effect upon its approval.


