 "TERMS OF REFERENCE/ CONDITIONS:

1) All Food Supplies shall be subjected for inspection prior entry of the jail premises. Inspection Group is composed of GSO staff, representative of the Governor, Security Control Officer/Mess Officer, Jail Welfare Officer/ representative and two (2) PDL from jail main building and annex building.

2) Schedule of delivery of food/ Food Supplies

Breakfast - on or before 6:00AM daily
 Lunch and Dinner - on or before 8:00AM daily

3) Meat products, fish, vegetables and fruits in season shall be delivered on or before 8:00AM daily while other supplies shall be delivered once a week or as need arises.

4) Should the Food Supplies delivered are not acceptable or rejected by the inspection team for valid reasons, the supplier shall immediately replace the items so as to avoid delay in the preparation of food.

5) Menu prepared and approved by the Provincial Nutritionist shall be strictly followed. For Breakfast, rice and viand and fruit in seasons shall be served, instead of bread, coffee and margarine.

6) Food supplier shall submit the necessary papers in support to the preparation of subsistence voucher such as Delivery Receipts, Official Receipts and other necessary document. Subsistence voucher can be prepared weekly." Purpose: For use of Provincial Jail Persons Deprived of Liberty (PDL) from September to December 2023 (122 days) from the date of the notice to proceed.
