Description

INVITATION TO BID FOR THE IMPROVEMENT OF MOTORPOOL BUILDING (EXPANSION OF OFFICE AREA) (BGY. IRAWAN, PUERTO PRINCESA CITY, PALAWAN)

1. The Provincial Government of Palawan, through the Locally Funded Fund (OBR No. 300-24-02-00782) intends to apply the sum of Two Million Two Hundred Thousand Pesos Only (Php 2,200,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the IMPROVEMENT OF MOTORPOOL BUILDING (EXPANSION OF OFFICE AREA) located at BGY. IRAWAN, PUERTO PRINCESA CITY, PALAWAN (Project Reference No. B2 GF PEO 24-02-012). Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Provincial Government of Palawan now invites bids for the above Procurement Project. Completion of the Works is required within one hundred twenty (120) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. A Certificate of Site Inspection which shall be issued by the Provincial Engineering Office shall be required and must be submitted as part of the Technical Component of the bid in order for the prospective bidder to determine the general characteristics and condition of the project such as the location and the nature of the work, geological

conditions at the site, communication facilities and availability of construction aggregates and other materials, labor, water, electric power and access roads; and other factors that may affect the cost, duration and execution or implementation of the contract.

5. Interested bidders may obtain further information from Bids and Awards Committee (BAC) Secretariat, Provincial Government of Palawan and inspect the Bidding Documents at the address given below during office hours. Monday to Friday, 8:00 AM to 5:00 PM.

6. A complete set of Bidding Documents may be acquired by interested bidders on February 27, 2024 from given address and website/s below, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos only (P5, 000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees if it will be presented in person, or through electronic means.

7. The Provincial Government of Palawan will hold a Pre-Bid Conference on March 6, 2024 at 2:00 PM at the BAC Conference Room, East Wing, 2nd floor, Gov. Ramon V. Mitra Building, Capitol Compound, Puerto Princesa City, Palawan, which shall be open to prospective bidders.

8. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before on or before 1:30 PM of March 20, 2024 at the Office of the BAC Secretariat, East Wing, 2nd floor, Gov. Ramon V. Mitra Building, Capitol Compound, Puerto Princesa City, Palawan. Late bids shall not be accepted.

9. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.

10. Bid opening shall be on 2:00 PM of March 20, 2024 at BAC Conference Room, East Wing, 2nd floor, Gov. Ramon V. Mitra Building, Capitol Compound, Puerto Princesa City, Palawan, Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
